NOTICE TO DOG OWNERS

Dog License Renewal and Delinquent Fees Effective April 1, 2026

Beginning April 1, 2026, all dog owners who have not renewed their dog's license for the previous year will be required to pay both:

- 1. The 2025 dog license plus (\$10.00) late fee for the unpaid year, and**
- 2. The new license fee for the current year.**

To avoid additional charges, please make sure your dog's license is renewed before March 31, 2026.

Licensing your dog helps ensure compliance with State & Town By-Laws, supports animal control office services, and assists in returning lost pets to their owners.

COST BREAKDOWN:

Male & Female Dogs \$25.00 per Dog (per year)

Spayed & Neutered Dogs \$6.00 per Dog (per year)

PLUS an ADDITIONAL

\$10.00 Late fee per Dog licensed after July 1, 2026

Fees can be paid in cash, check or credit card

(Note: Unibank will charge an additional service fee for credit/debit cards used)
